A message from Board Chair Marion McGeein



It's difficult to put 2020 into perspective.

In the final year of the library's 2018-2020 strategic plan, how do we step back and measure and compare library use and statistics considering the library was significantly impacted by COVID-19?

While it is important to consider traditional library statistics, such as circulation, visits and program attendance, it is perhaps more important to recognize the agility of the Brantford Public Library and its staff as they faced unprecedented challenges.

As soon as the library closed in mid-March, Library staff created an online membership form, designed online programming (pictured on the cover) and experimented with new digital lending models for eBooks and audiobooks. All in an effort to respond to our resident's changing needs and their need to feel connected during a time of isolation and uncertainty.

Safety procedures and protocols were also developed to keep customers safe as the library gradually re-opened under provincial legislation.

I thank all library staff for their willingness to return to work and serve our community. I also thank our residents for observing safety protocols and being open to trying things like eBooks and audiobooks.

If one thing was certain in 2020, it is that both the library and Brantford residents are resilient, patient and compassionate.

More than 260,000 ebooks, audiobooks and digital magazines and newspapers were downloaded in 2020, which was a 50% increase from 2019 use.

Many customers reported being pleased with how easy digital services were to use.



Fine Free Approval

In November, the Library Board approved moving to a Fine Free model. This approval allowed library staff to prepare for a move to a fine-free system in 2021.



Restructuring

Various vacancies across the organization allowed for an internal, costneutral restructuring that leveraged existing skills within the staff complement and addressed gaps. This new model also features increased attention on library collections, which include local history and maker resources.
